RECITALS

- (A) The Licensor is proprietor of and beneficially entitled to the copyright and all other rights of a like nature in the artwork/designs hereinafter referred to as "the Works". (Particulars of which are set out in schedule 1).
- (B) The Licensor is willing to grant a licence to the Licensee to reproduce the Works onto **MEDIA TYPE** ("the Products") as manufactured and sold by the Licensee and to sublicense this right to reproduce the Works onto the Products on such terms as the Licensee thinks fit.

IT IS HEREBY AGREED AS FOLLOWS:

1. Licence

In consideration of the sums paid by or to be paid by the Licensee, the Licensor as beneficial owner grants to the Licensee by way of licence:

- a. The exclusive right to all the copyright in the Works and the rights attached to such copyright extending to all countries of the United Kingdom by virtue of their respective copyright laws for the purposes of manufacturing and selling the Products.
- b. The exclusive right to reproduce and print the Works onto the Products and to publish and sell the Works to the extent that the Works form part of the Products throughout the United Kingdom (including the right to sublicense the reproduction and printing of the Works onto the Products and for publication and sale of the Works to the extent that the Works form part of the Products throughout the United Kingdom) for the full term of such copyright.

2. Duration

This licence shall commence on **DAY MONTH YEAR** and will continue on Licence for 12 months.

3. Warranties

The Licensor warrants that:

- a. It is the owner of the copyright in the Works and the Works are or will be its original work and the Works have not been and will not be copied from any other work or material;
- b. It has granted no other licences or made any assignment in respect of the Works;
- c. To the best of the Licensors knowledge, the reproduction, printing, publication and sale of the Works in relation to their use on the Products will not infringe the rights of other third parties.

4. Further Assurances

The Licensor undertakes at the request and expense of the Licensee to do all acts and execute all documents which may be necessary to confirm the rights of the Licensee hereby given whether in connection with the enforcement of this licence or otherwise.

5. Infringements

The Licensor will take all reasonable steps available to restrain infringements by third parties of the copyrights in the Works which might, if not restrained, damage the ability of the Licensee to exploit its right thereunder.

6. Law and Jurisdiction

This licence shall be construed and governed in accordance with the laws of England and the parties hereto submit to the jurisdiction of the English courts of law for this purpose.
